

12 Days of Giveaways Contest

Official Rules

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

TekSavvy Solutions Inc.'s 12 Days of Giveaways Contest (the "Promotion") is open only to legal residents of Canada who are at least eighteen (18) years of age at the time of entry. Void where prohibited by law. Employees of TekSavvy Solutions Inc., D-Link Corporation or any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production, execution or distribution of the Promotion and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members (people who share the same residence at least three (3) months out of the year) of each such employee are not eligible. Participation constitutes entrant's full and unconditional agreement to these Official Rules and the Sponsor's decisions, which, subject to applicable law, are final and binding in all matters related to the Promotion. The Sponsor's computer is the official timekeeping device for this Promotion. The time at which an entry is received by the Sponsor will be the time at which it is received by the Sponsor's mail server or web server (as applicable) as determined in accordance with the applicable server's clock.

During the Promotion Period, visit www.facebook.com/TekSavvySolutionsInc, fill out the online entry form in full and submit the form. **Limit one (1) entry per person during the Promotion Period.** A person entering must provide a valid email account associated with a domain that can be identified by a reverse domain name search as part of his/her contact information. Multiple participants are not permitted to share the same email address. Any attempt by any participant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that participant's entries and that participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for late, incomplete, invalid, unintelligible or misdirected registrations, which will be disqualified. Due to legal requirements in Canada, the winner is required to correctly answer, unaided, a mathematical skill-testing question administered on the contest entry form in order to be eligible for the prize.

On each of the twelve (12) weekdays (Monday to Friday) between December 26, 2011, and January 10, 2012, the Sponsor will conduct a random draw to select one (1) entry for the prize described below from all valid entries received during the Promotion Period. The selected entrant will be contacted by email, using the information provided with the entry. The selected entrant's

name will be posted on TekSavvy's Facebook and Twitter pages. If a response to the email message or online post is not received within five (5) business days, the selected entrant will be notified at the phone number provided on the contest entry form. The selected entrant, upon responding, may be declared a winner subject to verification of eligibility and compliance with the terms of these rules. Failure to respond to the initial email, post or phone call within five (5) business days of date of notification will result in disqualification. If the selected entrant cannot be contacted, or if the prize or prize notification is returned as undeliverable, the selected entrant forfeits the prize and the initial selected entrant will have no further recourse against the Sponsor or any person or company associated with this Promotion. In the event that a selected entrant is disqualified for any reason, the Sponsor will award the prize to an alternate entrant by random drawing from among all remaining eligible entries, and following the same steps as outlined above for the initial selected entrant. Subject to applicable law, the Sponsor's decisions as to the administration and operation of the Promotion and the selection of the entrant are final and binding in all matters related to the Promotion.

The selected entrant may be required to show proof of being the authorized account holder.

Each of the twelve (12) winners will receive one (1) Boxee media centre. Approximate retail value of each prize is \$199, which may vary based on rates available at time of receipt. No cash equivalent will be given for the prize.

The Sponsor reserves the right to cancel, suspend and/or modify the Promotion, or any part of it, if any fraud, technical failures or any other factor beyond the Sponsor's reasonable control impairs the integrity or proper functioning of the Promotion, as determined by the Sponsor in its sole discretion. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Promotion; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Promotion; (4) technical or human error which may occur in the administration of the Promotion or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Promotion or receipt or use or misuse of any prize. In the event that production, technical, seeding, programming or any other reasons cause more than stated number of prizes as set forth in these Official Rules to be available and/or claimed, the Sponsor reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims.

The Promotion is governed by the laws of Ontario and the laws of Canada applicable therein, and is subject to all applicable federal, provincial and municipal laws and regulations and is void where prohibited by law. Participation constitutes entrant's full and unconditional agreement to these Official Rules and the Sponsor's decisions, which are final and binding in all matters related to the Promotion. By entering the Promotion, the entrant agrees that the courts of the Province of Ontario, Canada shall have jurisdiction to entertain any action or other legal proceedings based on any provision of this Promotion's Rules and Regulations or the running of

this Promotion.

The Sponsor reserves the right, in its sole discretion, to terminate, modify or suspend the Promotion, or modify the Promotion Rules and Regulations at any time for any reason whatsoever.

The Sponsor reserves the right to contact entrants and all other individuals whose email address is submitted as part of the Promotion. No further marketing communications will be received by entrants unless entrants provide explicit permission to do.
