ORDER

UPON MOTION in writing by the applicants Rogers Media Inc. and Rogers Communications Inc. to amend Schedule 1 of the Court's Judgment dated July 9, 2024, to add

additional Protected Live Content in relation to which the applicants, or some of them, have exclusive rights to communicate live sports events to the public in Canada;

AND CONSIDERING that paragraph 19(a) of the Judgment dated July 9, 2024, contemplates that the applicants may file up to two motions to amend Schedule 1, without leave of the Court;

AND CONSIDERING that at the time of filing this motion, the applicants had previously filed five motions pursuant to paragraph 19(a) of the Judgment;

AND CONSIDERING that by Order dated September 4, 2025, this Court granted the applicants leave to file an additional motion pursuant to paragraph 19(b) of the Judgment, to amend Schedule 1 of the Judgment to include the 2025-2026 National Hockey League season, including the 2026 Stanley Cup playoffs and final series;

AND REVIEWING the motion record filed by the applicants, including the affidavits of Shawn Redmond sworn on September 4, 2025 (which incorporated and supplemented the evidence filed in his affidavit sworn on April 8, 2024, filed earlier in this proceeding), and of Julie Morin sworn on September 8, 2025, and the written submissions of the applicants on this motion; and recalling the application materials that were before the Court leading to the Judgment and Reasons dated July 9, 2024, the motion materials leading to the Orders dated July 12 and 23, 2024, and the prior Orders amending Schedule 1 of the Judgment (in particular, the Order dated October 3, 2024, adding the 2024-2025 National Hockey League Season to Schedule 1 of the Judgment);

AND NOTING that all the other parties appearing on the application have been given notice of the applicants' motion and that none of the Third Party Respondents have advised the Court that it opposes the motion or intends to make submissions;

AND NOTING that the applicants advised, in their written representations, that they do not presently propose to extend the two-year period in paragraph 25 of the Judgment;

AND CONSIDERING the requirements for the amendment of Schedule 1 as contemplated by the contents of the Court's Judgment and Reasons dated July 9, 2024, and subsection 39.1(1) of the *Copyright Act*, RSC, 1985, c C-42;

AND BEING SATISFIED on the evidence, information and submissions before the Court that the copyright owners need not be made parties to this motion to amend Schedule 1 of the Court's Judgment dated July 9, 2024, owing to the exception in paragraph 41.23(c) of the Copyright Act;

AND DETERMINING that the definition of "Protected Live Content" in Schedule 1 of the Court's Judgment dated July 9, 2024, should be amended as proposed by the applicants to add the 2025-2026 National Hockey League season, including the 2026 Stanley Cup playoffs and final series;

THEREFORE THIS COURT ORDERS that:

1. Schedule 1 of the Court's Judgment dated July 9, 2024, is amended to add the underlined contents to item 1, as follows:
